For 50 years, CAEL (the Council for Adult and Experiential Learning) has helped create impact for our members and clients as a nonprofit focused on supporting the creation of sustainable education-to-career pathways and fueling equitable economic mobility and community prosperity for all. We are passionate about removing barriers to success for adult learners and workers in all that we do. **Here are some highlights from our history.**

1974-1983 | CAEL IS ESTABLISHED

Begins work to develop prior learning assessment (PLA).

Holds first annual conference.

Becomes a 501(c)(3) with a staff of five.

W.K. Kellogg Foundation funds \$1 million grant.

Founded with 10 institutional members and a Carnegie Corporation grant

1984-1993 | EXPANSION INTO WORKFORCE DEVELOPMENT

Publishes standard guides: Earn College Credit for What You Know, PATHWAYS to the Future, Assessing Learning: Standards, Principles, and Procedures.

Receives first U.S. Food and Drug Administration grant and Joyce Foundation award grant.

Headquarters relocation from Maryland to Chicago, IL; Pam Tate becomes president.

Launches first national survey of PLA practices with U.S. institutions and releases *Prior Learning Assessment: Results of a Nationwide Institutional Survey.*

Expands PLA work internationally, including Asia and Canada.

UAW-Ford union program, Mountain Bell Telephone and CWA/IBEW, and Scott Paper workforce development projects



1994-2003 EXPANDING INDUSTRY-EDUCATION PARTNERSHIPS

Initiates public policy work with Pew Charitable Trust, the U.S. Department of Education, and the MacArthur Foundation.

Designs one-stop career centers in Massachusetts, Chicago, IL, and Colorado.

Launches "Partnership for a Smarter Workforce," funded by the National Association of Manufacturers, the National Institute of Standards (NAM) and Technology (NIST), and others.

W. K. Kellogg Foundation funding helps create a Commission for a Nation of Lifelong Learners.

Begins adult advising services for Bell Atlantic, Chase Manhattan Bank, and Target Group, Inc.

Receives grant from the U.S. Department of Labor, partners with GTE Government, Systems Corporation, and the MA Industrial Services Program.



Creates industry coalition NACTEL with AT&T and Verizon, labor unions, and Pace University; creates EPCE, an energy industryeducation partnership coalition



Receives \$2 million from U.S. Department of Labor to develop a health care career ladder and program to increase the number of CNAs, LPNs, and RNs, including a "groundbreaking apprenticeship program"

Launches public Returning to Learning® workshops.

Manages Partnership for a Smarter Workforce, with NAM, the Corporation for Business, Work and Learning, and NIST to support training needs in Indiana.

Begins work to manage employer's tuition reimbursement programs with BetzDearborn, Inc., Chase Manhattan Bank, Media One Group, and BlueCross BlueShield of IL.

Administers learning program for Six Flags Over Texas.

Publishes principles of best practices for "Adult Learner Focused Institutions."

Advocates for Individual Learning Accounts (LILAs).

Implements transition program for Levi Strauss & Co. displaced workers; adds seven transition centers.

ALFI (now Adult Learner 360™) launches; ALFI Principles of Effectiveness framework emerges.

AACRAO, ACE, and CHEA reendorse CAEL's PLA principles in *The Principles of Good Practice in the Assessment of Experiential Learning*.

Organizes WorkforceChicago 2.0, with chairs of Boeing Co. and Exelon Corp.

Launches ALFI toolkit with support from Lumina Foundation and the Pew Charitable Trusts to develop the Principles for Effectively Serving Adult Learners. 200 institutions provide input.

Releases second edition of *Assessing Learning: Standards, Principles & Procedures* with updated standards.

Partners with NCHEMS to release Adult Learning in Focus: National and State-by-State Data.

Releases Prior Learning Portfolios: A Representative Collection, a higher education reference tool.

Launches online PLA program for adult learners: LearningCounts.

Releases Underserved Students Who Earn Credit Through Prior Learning Assessment (PLA) Have Higher Degree Completion Rates and Shorter Time-to-Degree research.

Supports creation of the Veterans Higher Education Affinity Group (VHEAG).

The Learning That Maturity Brings: An Analysis of the Value of Prior Learning Assessment for Mature Learners research brief shows mature learners earned more PLA credits than did younger age groups.

Publishes *Competency-Based Education*, summarizing white papers, summits, new program development, and public policy movement on CBE.
